PLAYER WAIVER AND RELEASE OF LIABILITY  
IMPORTANT – PLEASE READ AS IT MAY AFFECT YOUR RIGHTS

In consideration of being allowed to participate in any way in the Sportsplex USA athletic/sports program, related events and/or activities, I hereby acknowledge, understand and agree that: (a) The risk for injury from my/my child's participation in the sports activities involved in this program is significant, including the potential for permanent paralysis and death; and while particular rules, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist; and (b) I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full and complete responsibility for any injury or damage arising out of my/my child's participation in the Sportsplex USA athletic/sports programs, related events and activities; and (c) I willingly agree to comply with the above stated terms and conditions for participation. If I observe any unusual or significant hazard during my presence or participation, I will remove myself/my child from participation and bring such to the attention of the nearest official immediately; and (d) I hereby release and hold harmless Sportsplex USA, Inc and the City of Poway, and their agents, employees and officers with respect to any and all claims for injury, loss or damage to person or property, whether arising from the negligence of the releasees or otherwise.
